



## **HOCKEY-FRENZY - 10 Week SWEEPSTAKES**

### **\$20 Fundraiser - OFFICIAL RULES 2023**

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

**1. The Sweepstakes:** The Hockey-Frenzy Sweepstakes (the "Sweepstakes") begins on 3/1/2023 at 11:59PM Eastern Standard Time ("EST") and ends on 1/21/2024 at 11:59 PM EST (the "Sweepstakes Period"). Sponsor observes Daylight Savings Time when applicable.

**2. Eligibility:** The Sweepstakes is open to U.S. residents currently residing in the 50 United States including the District of Columbia who are at least eighteen (18) years of age and the age of majority (19+ in AL and NE; 21+ in MS) or older as of the date of entry. Participation constitutes participant's full and unconditional agreement to these Official Rules and to Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

Entries must be received before the deadline dates listed below in order to qualify for the respective week's drawing. However, once an entry is received, the entrant is automatically eligible for all listed drawings that are not yet completed as of the date the entry was received.

No Game Cards will be available after the sweepstake has begun.

**3. Sponsor:** Sweepstakes is sponsored and administered by FUNd-Frenzy, LLC ("Sponsor"). Sponsor is not affiliated with or endorsed by any of the charitable organizations which may benefit from the Sweepstakes.

**4. How to Enter:** During the Sweepstakes Period, you may enter one of four ways: (1) In-person visit: Stop by a local non-profit organization participating and purchase a FUNd-Frenzy Ticket, which contains a membership access code that allows you to access over \$20 worth of everyday discounts and savings, at which time you will receive your promotional sweep-stakes game card ("Game Card") and be automatically entered to win; (2) Event: Attend any charity event sponsored by a participating non-profit organization, purchase a FUNd-Frenzy Ticket for \$20.00, and you will receive your Game Card and be automatically entered to win; (3) Solicitation: A door-to-door non-profit organization representative may offer you a chance to purchase a FUNd-Frenzy Ticket for \$20.00, which purchase will cause you to be automatically entered to win; (4) Alternate method of entry: Stop by any participating non-profit organization and ask for a free Game Card request form, complete the form with all required information, and mail it to the address shown on the request form along with a self-addressed stamped envelope. Your request form must be postmarked on or before the Weekly Deadline date to qualify for that week's prize. A Game Card will be assigned to you and mailed in the return envelope sent with your form. Even if you do not receive the Game Card before the weekly game for which you qualify, you will still be entered to win. Regardless of the method of entry used,

participants may enter up to five (5) times per residence, but may not enter more than one time per day.

Sponsor and its agents, affiliates, subsidiaries, representatives, or service providers may use participants' personal information submitted with entry for purposes of prize fulfillment and/or for future marketing.

Use of any bulk, robotic, automatic, programmed, third-party or similar entry method or entering more than the permitted number of times will void all entries and result in disqualification. A participant may not enter more than once by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than the stated number of entries by using multiple and/or different identities, forms, registrations, email addresses, logins, or any other methods will void that participant's entries, and that participant may be disqualified at Sponsor's discretion. In the event of a dispute as to any entry, the authorized account holder of the email address used to enter the Sweepstakes will be deemed to be the participant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder to the Sponsor or forfeit the prize. Entries that are incomplete, illegible, corrupted, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole discretion.

**5. Selection of winners:** Each Game Card contains ten randomly generated, four-team combinations ("Team Combination"), which are randomly assigned to the Game Card. The total number of possible combinations appearing on a single Game Card is 35,960. Each Team Combination is associated with a specific week in the football season during the Sweepstakes Period. After the conclusion of each week in the Sweepstakes Period (on or about each Tuesday at 3:00 AM EST), Sponsor will calculate the total number of points and total yards of offense scored by each Team Combination (if one or more teams in a Team Combination did not play in the respective week, those teams will be assigned their point total from the previous week). These totals can be viewed at [www.FUNd-Frenzy.com](http://www.FUNd-Frenzy.com) or by scanning the QR code on a Game Card. During each week of the Sweepstakes Period, a set of 70 winners will be determined. This group will consist of two categories: (a) participants holding Game Cards with the Team Combinations that achieve the 35 highest total points, and (b) participants holding Game Cards with the Team Combinations that achieve the 35 lowest total points. In the case of a tie between the total scores of multiple Team Combinations within a given week, any Game Card with a score matching the 35th lowest and highest will also qualify as a winning entry.

In addition to the weekly prizes, there will be three (3) grand prizes awarded at the conclusion of the Sweepstakes Period.

Each Game Card has 703 chances to win. Odds of winning in a single weekly game are 1 in 514. Odds of winning a grand prize are 1 in 11,986. Odds of winning at least once during the entire Sweepstakes Period are 1 in 51.

The winners will be notified by email within three (3) business days of the drawing date. Except where legally prohibited, each winner must sign and return, within seven (7) days of being notified, an Affidavit of Eligibility, Liability/Publicity Release, and/or other documentation reasonably required by Sponsor (collectively, "Winner Documentation") in order to claim his/her prize. If a winner cannot be

contacted in person via email after the first attempt to contact him/her, or if he/she fails to complete and return all required Winner Documentation or other required document within the required time period, or in the event that a winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner selected by a random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain unawarded.

Verification of Potential Winners: ALL WINNERS ARE SUBJECT TO VERIFICATION AND DUE DILIGENCE BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. A PARTICIPANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL PARTICIPANT'S ELIGIBILITY HAS BEEN VERIFIED.

**6. Prize:** For each of the specified weeks of the Sweepstakes Period, Sponsor will award 70 prizes (35 prizes to the holders of the 35 highest scoring Team Combinations, and 35 prizes to the lowest). Prizes awarded for each specified week during the Sweepstakes Period comprise a pool valued at a minimum of \$3,475, as follows:

- Minimum 1 prize with a value of \$450
- Minimum 1 prize with a value of \$300
- Minimum 1 prize with a value of \$150
- Minimum 1 prize with a value of \$125
- Minimum 1 prize with a value of \$75
- Minimum 30 prizes with a value of \$50 each
- Minimum 35 prize with a value of \$25 each

The Grand Prizes consist of the following:

- Minimum 1 Grand Prize with a value of \$2,500
- Minimum 1 Grand Prize with a value of \$1,500
- Minimum 1 Grand Prize with a value of \$1,250

Prize consists of only the item specifically listed as the prize. Any and all applicable federal, state, and local taxes and all fees and expenses related to acceptance and use of prizes not specifically stated herein are the sole responsibility of the individual prize winner. Prize cannot be substituted, assigned, or transferred. Sponsor will not replace any lost or stolen prizes.

**7. General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control, including but not limited to any cyber-attack or hack, impairs the integrity or proper functioning of the Sweepstakes or the awarding of the prizes, as determined by Sponsor in its sole discretion. Sponsor is not responsible for lost, late, incomplete, damaged, stolen, misdirected, or illegible entries; lost, interrupted, or unavailable network, server, or other connections, garbled transmissions or miscommunications, telephone transmission problems; computer or software malfunctions or damage to a user's computer equipment (software or hardware); technical failures; or other errors or malfunctions of any kind whether human, mechanical, electronic, or otherwise. Proof of submission of entry will not be deemed proof of receipt by Sponsor. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. THE SWEEPSTAKES IS VOID WERE PROHIBITED BY LAW AND OUTSIDE THE UNITED STATES, AND IS SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS, REGULATIONS, AND ORDINANCES.

Sponsor reserves the right at its sole discretion to disqualify any individual it finds to be attempting to tamper with or undermine the entry process, any website associated with the Sweepstakes, and/or the legitimate operation of the Sweepstakes; to violate the Official Rules; or to act in a disruptive manner or with the intent to annoy, abuse, threaten, or harass any other person. If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor may, in its sole discretion, void any suspect entries and (a) modify the Sweepstakes or suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; or (b) award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment.

contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, webmasters, and their respective officers, directors, employees, representatives and agents (the "Released Parties") are not responsible for: (1) any incorrect or inaccurate information, whether caused by participants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to alterations, malfunctions, interruptions, cyber-attacks, hacks, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; (5) any claims based on obtaining, maintaining, insuring, utilizing, transferring or operating the prize; and (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from participant's participation in the Sweepstakes, the receipt or use or misuse of any prize. Disputes.** Except where prohibited, participant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the State Court located in Orange County, New York or by the United States District Court for the Southern District of New York; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred and in no event attorneys' fees; and (3) under no circumstances will participant be permitted to obtain awards for, and participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the participant and/or Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any choice of law or conflict of law rules (whether of the State of New York or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of New York.
